Important Notes

Attendees must wear suitable and appropriate clothing for the course in which they are attending. As a large majority of the work they are likely to be doing involves practical work it is likely that some form of permanent marks will be made on the attendees clothing even when wearing the provided protective layers.

Particularly if on a Circles Farm course attendee must wear suitable clothing for working outdoors in the current season on such activities that are likely to take place on a farm. Suitable protection from the sun should be provided during hot weather, i.e. hats or caps and tops which cover the shoulders. We will not routinely apply sun cream and failure to provide suitable protection from the sun may result in the attendee missing activities.

All our activities are risk assessed and the student will be kept safe while at Circles. However, you should be advised that some activities are classed as 'Risk Present'. There are also risks associated when working/handling animals.

Students should be provided with a packed lunch and ample drinks for the day. Please refer to the list of banned items on the next page when preparing a student's packed lunch.

(Tap water is available along with a toaster, kettle and microwave for student use)

If students arrive in unsuitable clothing they may be asked to leave. This could include clothing with offensive designs on, clothing that does not cover an appropriate amount of the body, etc. All students are required to wear tops that cover their shoulders and torso at all times.



Banned Items

To minimise disruption to the working day a number of items are considered 'Banned' and should at no time be brought with the student to Circles. If a student is found with any of the following they will be confiscated and not returned to the student directly but either sent to the school or directly home.

- Expensive electronic equipment
 - Exceptions
 - Mobile phones, if students bring mobile phones into the centre we require them to be handed in at the beginning of the day to be kept in a locked box while on site. We can not be held responsible for lost/damaged phones.
 - Camera's, if a student chooses to bring their own camera to document their work progress Circles Education Centre can not be held responsible for lost/damage. We will provide camera equipment when needed.
- Cigarettes, lighters and matches
 - If students bring cigarettes, lighters, etc with them they are to be kept in their bags and not left on display. If they are seen by staff when they should be away they will be confiscated and destroyed. No exceptions.
- Expensive jewellery including watches
- **Energy Drinks**, e.g. red bull, lucozade, etc
 - Energy drinks of any description will be confiscated and disposed of.

Any student found with offensive weapons, illegal drugs and any other form of illegal or inappropriate material will be reported to the, Parent/Guardian, School and Police and may result in their placement being suspended/cancelled.
